### **OLD BUSINESS**

### General Road/Zoning Update

Road Supervisor/Zoning Administrator Booge reported the roads are in good shape overall. Grading was done on the portion of Black Lake Road that dust control was applied to because of the wash boarding. Mowing started last Tuesday and brushing should start next week. Work on Turgi Hill Rd should begin on August 15<sup>th</sup>. He also asked the Board for permission to get an estimate from Steve Schaubhut for patching on Idlewild Dr. Motion by Vice Chair McBride to obtain an estimate for the patching, second by Chair Anderson. Motion carried 4-0.

### Werner Road

Road Supervisor Booge reported that the earliest that work would begin is the week of August 11th.

### Old Long Lake Road

Discussion on whether to reconstruct both the east and west portions at the same time or to do one-half at a time was had. Concern about spending the money to do the whole road and depleting the road fund was discussed. The change in the width of the road surface if the project was done in two parts was also a concern as the road would narrow where the east meets the west. It was decided to do the east side in 2026 and the west side at a later date because of the availability of funds. Motion by Supervisor Haugen to do the east side with the addition of road signs indicating the road narrows when entering the west portion. Second by Chair Anderson. Motion carried 4-0.

## Conditional Use Permit/Planning Commission

The planning commission met on August 4th at 6:30 p.m. to discuss the Linn's conditional use permit request. The recommendation brought to the Board was to approve the CUP. Motion by Chair Anderson to approve the CUP, second by Supervisor Haugen. Motion carried 4-0.

#### **Website Domain Name Change**

Clerk informed the Board that a new Minnesota law requires that all government entities have a .gov domain. A new name has been obtained from .gov but is not yet set up for our use.
